NOTIFICATION

No.F 3/03/2007HF.II/ : Whereas the Lt. Governor of the National Capital Territory of Delhi is satisfied that the Health Services in the National Capital Territory of Delhi are essential services for maintaining uninterrupted health services and services necessary for the life of the community in the National Capital Territory of Delhi;

And whereas the Lt. Governor of the National Capital Territory of Delhi is further satisfied that in the public interest, it is necessary and expedient to prohibit the strike / agitation by the doctors/employees of Guru Tegh Bahadur Hospital, Dilshad Garden, Delhi, under the administrative control of Health and Family Welfare Department, Government of NCT of Delhi;

Now, therefore, the Lt. Governor of the National Capital Territory of Delhi in exercise of the powers conferred by section 3 read with section 4 A of the Haryana Essential Services Maintenance Act, 1974 (Haryana Act No. 40 of 1974) as extended to the National Capital Territory of Delhi, vide Government of India, Ministry of Home Affairs Notification No. GSR 526(E) dated 30.07.93 hereby declares the above said services as essential services and prohibits the strike / agitation by the doctors/employees of Guru Tegh Bahadur Hospital, Dilshad Garden, Delhi, for a period of six months in the National Capital Territory of Delhi.
