

GUIDELINES FOR CANDIDATES

1. Due to receipt of large number of applications for the post of Assistant Public Prosecutor (on contract basis), the selection process has been changed. There will be a written examination and the candidates shortlisted on the basis of this exam will be called for interview.
2. All the eligible candidates for the post have been issued Admit Card for the written examination to be held on 28th September, 2014 (Sunday) at J.V.S.D. Girls Sr. Secondary School, D-2 Link Road, Opposite Hanuman Ji Statue, Near Jhandewalan Metro Station, Karol Bagh, New Delhi-110005. The duration of the examination will be two hours i.e. from 11.00 AM to 1.00 PM.
3. The OMR based written examination will consist of 100 multiple choice questions each carrying one mark and the time period for attempting the paper would be two hours. **There would be a negative marking of 1.00 (one) mark for every wrong answer.** Answers to the questions are to be given by the candidates in the computerized OMR sheet with ball point pen only by darkening the circles. The candidates should bring two blue/black ball point pens for the examination.
4. The question paper will consist of questions from the following subjects / Acts :-
 - (i) Various Central Criminal Acts, viz. Arms Act, Dowry Prohibition Act, Juvenile Justice Act, Information Technology Act etc.
 - (ii) Criminal Procedure Code
 - (iii) Indian Penal Code
 - (iv) Indian Evidence Act
5. All the eligible candidates have been despatched Admit Cards for the written examination. The candidates may check their names in the lists of accepted / rejected applications uploaded on the Home Department website.
6. If any candidate does not receive the Admit Card upto 16/9/2014, he/she may contact Superintendent (Home-I), Home Department, Govt. of NCT of Delhi, 5th Level, C-Wing, Delhi Secretariat, I.P. Estate, New Delhi for issue of duplicate Admit Card latest by 25/9/2014 upto 5.00PM. Thereafter, no request for duplicate Admit Card shall be entertained. The candidate making such a request should bring his/ her identity proof as mentioned in para-10(iii). In case of any query related with the written examination the Superintendent (Home-I) may be contacted on telephone Nos. 23392001, 23392002, 23392003, 23392004 Extn. Nos. 3525 and 3520.
7. The candidates appearing for the written examination are advised not to bring any mobile phones /pagers /calculators /bluetooth or any other electronic gadget to the examination centre as the same is strictly prohibited inside the Examination Centre. Authorities will not be responsible for its safety/loss. If any such device is found on the person of the candidate inside the examination hall, he/she will be disqualified from the selection process.
8. The candidature for examination/ interview is provisional subject to candidate's fulfilling the eligibility conditions. Please note that issuance of Admit Card does not constitute any offer of employment to you.

9. The Schedule of the examination will remain unaltered even if the date of examination is declared a public holiday.
- 10 The candidates appearing for the written examination are required to:-
- (i) Affix their recent self attested passport size photograph on the Admit Card and put their signature in the space provided.
 - (ii) Bring their Admit Card at the examination centre, failing which they will not be allowed to enter the examination hall.
 - (iii) Bring Photo ID Proof in original for verification purpose, failing which they will not be allowed to enter the examination hall. Photo ID Proof may include any one of following:-

Election ID, PAN Card, Driving Licence, Adhar Card or any photo identity Card issued by any Govt. organisation.
 - (iv) Reach the examination centre at least 45 minutes before commencement of examination (i.e 10:15 A.M on 28-09-2014) and occupy their seats in the respective classroom/Hall as per the seating Plan. No candidate will be allowed to enter the Examination Hall after the start of examination i.e. 11.00 AM.
 - (vi) Submit the Admit Card, question paper and answer sheet to the Invigilator at the end of the written examination. No candidate will be allowed to leave the examination hall without handing over of answer sheet, question paper and Admit Card to the Invigilator.
 - (vii) Not to indulge in copying or adopting any unfair means in the examination hall. Any candidate found indulging in any malpractice or in possession of any unauthorised material will be summarily disqualified from the selection process.
11. The candidates are advised to visit the Home Department website www.home.delhi.gov.in for result of the examination or any information related to the appointment to the post of Assistant Public Prosecutor.
